- 1. Provide a copy of company registration/incorporation certificates
- 2. Provide a copy of PIN/VAT certificates
- 3. Provide a copy of Bid security of 2% of the Bid Amount. The bid bond must be in form of Bank Guarantee from a reputable Bank or an Approved Insurance Company.
- 4. Provide copies of audited accounts for the previous three financial periods
- 5. Provide a copy of business profile
- 6. Discloser of Directors/partners
- 7. Proof of works of similar magnitude and complexity undertaken in the last five years.
- 8. Adequate equipment and key personnel for the specified types of works.
- 9. Sound financial standing and adequate access to bank credit lines.
- 10. Litigation history of the company (both court and arbitration cases).
- 11. Duly signed confidential business questionnaire.



12. Valid Tax Compliance

Further, the following tenders shall be treated as non-responsive and therefore subject to automatic disqualification:

- 1. A tender from the tenderer whose on-going project(s) is/are behind schedule and without an approved extension of time.
- 2. A tender from the tenderer who has been served with a default notice on on-going project (s) or a tenderer who has been terminated in a Government contract in the past and has not been reinstated in the Register of Contracts.
- 3. A Tender that is above or below by 10% of the official estimate.
